01. Commercial Property in Pilimathalawa

Then turn left on to carpet road and travel about 900 M and turn left on to road (cement interlock paved road) leading to “Yakgirilena Raja Maha Viharaya” and continue about 100 M and turn right on to private gravel road and travel about 30 M to reach the property located at dead end of the road.
